	<ul style="list-style-type: none"> ○ Matt provided opening remarks and thanked everyone for their service to the American University Neighborhood Partnership and thanked William for returning to the position of Co-Chair. ○ William reflected on the progress made in the partnership between the neighborhood and American University. William shared that his goal is to continue building on that relationship and towards the steering committee to focus on positive initiatives.

AU Updates	<p>Matt Bennett provided a few American University updates:</p> <ul style="list-style-type: none"> • President Alger's Inauguration (March 27-28): The official inauguration ceremony will be held on March 28. • Following President Alger's listening sessions last fall, AU has started the process of standing up several working groups that will contribute to the strategic plan. One of the working groups is focused on public engagement. Once the public engagement working group is established, there will be an

	<p>opportunity for them to engage the steering committee and community members to collect input. Then as progress moves forward, updates will be shared throughout the year.</p> <ul style="list-style-type: none"> • The strategic planning process will run from March to October, with all input consolidated into a draft plan by November. The final version will be reviewed by the Board of Trustees and is set to launch in January 2026. • Men's Basketball Update: The team is performing well, with an exciting season. They have upcoming away games, as well as a few remaining home games before the Patriot League tournament. • Terms of Reference Update: A future review of the terms of reference for the partnership will be conducted to ensure they remain relevant. This topic was mentioned in the last meeting, and wanted to point out that this will be a topic as the partnership moves forward. • AU is reviewing federal actions related to higher education that could affect funding and university operations. <p>Questions:</p> <p><i>The partnership to prepare for the strategic planning process and emphasize the work within the Engagement committee to show the importance of the partnership and the relationship with the neighborhood.</i></p> <ul style="list-style-type: none"> • The partnership will have space to do some of that preparation. The working group focused on community engagement will share their questions, but those are not the limitation. This is a chance to think big.
Campus Safety Conversation and Student Life and Safety Update	<p>Phil Morse provided a brief overview of the campus safety conversation and provided an update on progress since the presentation in December.</p> <ul style="list-style-type: none"> • AU's Security Working Group has been assessing the feasibility and implications of arming its police department in response to national concerns about campus safety. This review, part of a broader risk assessment conducted every five years, involved input from students, faculty, staff, alumni, parents, and neighbors. The group examined research and implementation factors associated with arming university police departments. Their findings and recommendations will be presented to the Board of Trustees next week after which a final decision will be shared. <p>Questions:</p> <p><i>What are the steps being taken to support student health and well-being, given that there is a correlation between shootings and mental health?</i></p> <ul style="list-style-type: none"> • AU's violence prevention program includes confidential reporting and early intervention by Student Affairs, police, HR, health, and counseling services. The university collaborates with the Metropolitan Washington

	<p>fusion center to monitor external threats in real time. Risk analysis informs countermeasures and community training to enhance safety.</p> <ul style="list-style-type: none"> • AU also has the Care Network which allows anybody in the AU community to submit a report about a student of concern, including that of well-being. AU's center for well-being programs operates individual counseling, group counseling, a 24/7 hotline, and telehealth counseling. <p><i>What are the steps to roll out the decision to the neighborhood? I have a concern about how the board's decision will be communicated to the neighborhood, especially if officers are armed.</i></p> <ul style="list-style-type: none"> • The survey was open to neighbors and was sent out broadly. AU is looking at all the scenarios and preparing for whichever decision is made and the best ways to communicate it to the full AU community, including neighbors. We are open to that conversation to determine the best ways to communicate with the community. <p><i>To clarify, what is being presented to the Board next week?</i></p> <ul style="list-style-type: none"> • The education, forums, survey, and research have informed a report with recommendations. The President of AU will review the report and recommendations and use that information to formulate a decision together with AU's Cabinet. The decision will then be presented to the Board of Trustees. While the Board will not be voting on the decision, their concerns and questions can have an influence. <p><i>What have Georgetown University, George Washington University, and other institutions done on this issue?</i></p> <ul style="list-style-type: none"> • Georgetown's officers are not armed with lethal force. GW is armed for those in their department that have the background and experience. It's unclear if Catholic University's officers routinely carry them, but they do have firearms. UDC is armed. Howard is armed. Trinity employs a security force that is unarmed. Gallaudet is unarmed. <p><i>I have a concern that the decision will be leaked before being properly communicated to the community.</i></p> <ul style="list-style-type: none"> • This effort has a broader focus than just simply arming AU police, but exploring the range of scenarios and circumstances, and the different pros and cons. • Whatever the outcome is, AU will have the appropriate communications plan in place to inform key stakeholders and ensure it is rolled out consistently.

	<p>Jonathan McCann provided updates on the construction of the Meltzer Center:</p> <ul style="list-style-type: none"> • The structural concrete and steel work is 100% complete • Exterior enclosure work is underway • Interior work is underway in the Sports Center Annex • Overall construction for the project remains on track for substantial completion by the end of 2025 <p>Questions</p> <p><i>No questions were raised</i></p> <p>Transportation and Parking</p> <p>Josh Finver provided updates regarding the DDOT annual TDM letter, the CaBi Station locations, and neighborhood parking enforcement.</p> <ul style="list-style-type: none"> • AU completed submission of annual report in December after sharing with the Transportation and Parking working group. • Per DDOT, the new CaBi stations at Fletcher Gate and the Spring Valley Building are to be completed in the spring. It will not take up parking spaces. • Since the start of the semester, AU has issued 142 tickets, with 36 in the area around Spring Valley. <p>Questions</p> <p><i>What is allowing the station to not take up parking spots?</i></p> <ul style="list-style-type: none"> • They are able to put half of the station on the street and half on the sidewalk. The part that they have on the street is part of an existing no parking area. The station will not block the view lines for cars.
<p>Community Relations and Engagement and Communications Update</p>	<ul style="list-style-type: none"> • Jason Millison and Beth Deal recapped the success of AU’s event for National Girls and Women in Sports day. • Upcoming events in March were highlighted such as the Sine Institute Fellows program and their seminar series, Spring Garden Prep 2025, and the inauguration of President Jonathan Alger. • The Jacobs Field Quarterly Sound Monitoring report will be sent to everybody at the end of February <p>Questions:</p> <p><i>How was the sports event communicated to the community and what was the turn out?</i></p> <ul style="list-style-type: none"> • The newsletter, Nextdoor, social media, and community listservs. This event had over a thousand attendees.
